-: Note :-

- (01) To avail benefits such as Fees relaxation under various schemes, candidates must submit an income certificate Issued by Tahsil for the year 2023-24 otherwise, they will not be eligible for any relaxation in the fees.
- (02) To claim benefits under the scheme for SEBC and EWS, the candidate is required to submit copy of Income Certificate (for the year 2023-24) Ration Card, Domicile, and Aadhar Card.
- (03) Other fees such as MUHS Enrolment, Eligibility, Development, and Ashvamedha & Sports fees as specified in the MUHS circular must be borne by the candidate to secure admission.
- (04) The above stated fees will be revised after confirmation from Fees Regulating Authority for the academic year 2024-25, which is still pending. Therefore, the fees will differ as per the new directions and will be applicable to all without exception.
- (05) For NRI Fees:- As per FRA decision dated 02/11/2023 fees up to 5 Times of the general seats fees will be charged for the students admitted in NRI / against NRI Seats. All rights regarding concession in the above are reserved by the Management of Institute.
